# **ENVIRONMENT:**

in accordance with the "VINCI Environmental guidelines" and the "VINCI environmental ambition":

## **ANTICIPATE THE ENVIRONMENTAL IMPACT**

- Take measures to assess and be transparent regarding emissions in your own business activities, including the value chain.

## **REDUCE THE IMPACT OF OUR ACTIVITIES**

- Reduce direct and indirect greenhouse gas emissions in accordance with the Paris Agreement.
- Strive to achieve the highest environmental standards in terms of conservation of natural resources, waste management and protection of biodiversity.

#### **USE ENVIRONMENTALY COMPATIBLE RESOURCES**

- Use resources responsibly, reduce and recycle the waste in the entire value chain.
- Be conscious regarding the design or use of materials and resources of goods with the entire lifecycle in mind.

#### PRESERVE NATURAL ENVIRONMENT

- Preserve the biodiversity, reduce the water footprint, and control the risks of water and soil pollution.

#### **HUMAN RIGHTS:**

in accordance with "VINCI's Guide on Human rights" and the "VINCI Declaration on Essential and Fundamental Actions Concerning Occupational Health and Safety":

#### **SOURCE MINERALS RESPONSIBLY**

- Avoid the use of minerals from conflict-affected and high-risk areas that contribute to human rights abuses, corruption, the financing of armed groups or other similar negative effects.

in accordance "VINCI's Code of Ethics and Conduct" and the "VINCI Anti-corruption Code of Conduct":
